### 1. SALIENT FEATURES

- Revenue from continuing operations decreased by R268 million to R2 604 million, from R2 872 million in the prior corresponding period.
- Headline earnings per share ("**HEPS**") increased by 32 cents per share to 23 cents per share from a loss of 9 cents per share in the prior corresponding period.
- Earnings per share ("**EPS**") increased by 58 cents per share to 29 cents per share, from a loss of 29 cents per share in the prior corresponding period.
- → A final distribution per share ("DPS") of 7 cents. (2020: Nil)
- Net asset value per share ("**NAVPS**") increased by 26 cents per share to 363 cents per share, from 337 cents per share in the prior corresponding period.

#### 2. DISTRIBUTION DECLARATION

The board of directors resolved to declare a final distribution of 7 cents per ordinary share (2020: 0 cents), in respect of the 12 months ended 31 March 2021, out of stated capital through the reduction of contributed tax capital ("distribution").
